#### **ORDER**

WHEREAS, the recognition was granted to the institution namely Aradhana College of Education, Rangareddy District, Andhra Pradesh vide SRC (NCTE) order no. F.AP/NEW/B.EdD/227/SRO/NCTE/2002-2003/6095 dt. 28.02.2003 for conducting B.Ed. course of one-year duration with an annual intake of 100 students.

- AND WHEREAS, the SRC in its 178th meeting held on 13-14th July 2009 considered the matter and decided to issue show cause notice of the institution has not shifted to permanent premises as per norms and standards and conditions mentioned in recognition order dated 28.02.2003/ not communicated the shifting of premises to the SRC and not paid the prescribed fees for shifting of premises.
- AND WHEREAS, a show cause notice was issued to the institution on 27.08.2009. 3. Reply was not received. On 31.12.2014, letters were issued to all existing institutions regarding notification of new Regulations 2014 seeking consent on their willingness for fulfilling the revised norms and standards before 31.10.2015.
- AND WHEREAS, on promulgation of NCTE Regulations, 2014, the institution submitted 4. affidavit dt.24.08.2015 for its willingness for adherence of provisions of new Regulations. A revised provisional recognition order was issued to the institution on 27.08.2015 for conducting B.Ed. course of two years duration with an annual intake of 100 (Two basic units) from the academic session 2015-16.
- AND WHEREAS, the institution submitted its written representation on 20.06.2016 along with relevant documents, staff list and shifting fee of Rs. 1, 50,000/- DD dated 13.05.2016. The SRC in its 316th meeting held on 07th-08th July, 2016 considered the shifting proposal and the committee decided Cause inspection for shifting of B.Ed (2 units), Ask VT to collect all relevant documents; and, check esp. adequacy of built up area for B.Ed (2units). The inspection of the institution was fixed, and intimation letter was issued to the institution on 18.07.2016. Accordingly, the inspection of the institution was conducted on 19.08.2016. The VT report received on 22.08.2016.
- AND WHEREAS, the SRC in its 321st meeting held on 28th to 30th September, 2016 6. considered the VT report and decided to issue show cause notice as per the decision of SRC, a show cause notice was issued to the institution on 22.10.2016.

- 7. AND WHEREAS, the SRC in its 365<sup>th</sup> meeting held on 31<sup>st</sup> October to 1<sup>st</sup> November, 2018 considered the non-submission of SCN reply and decided to issue SCN. As per the decision of SRC, a show cause notice was issued to the institution on 27.11.2018. The institution did not reply to the show cause notice till date.
- 8. AND WHEREAS, the Sub-Committee of the SRC in 380<sup>th</sup> meeting decided to issue Final Show Cause Notice to all such institution where reply to SCN has not been submitted by the institution. Accordingly as per the decision of SRC a Final Show Cause Notice was issued to the institution on 09.10.2019. The institution vide letter dated 05.12.2019 submitted its reply to the final show cause.
- 9. AND WHEREAS, the SRC in its 384<sup>th</sup> meeting held on 12<sup>th</sup> -13<sup>th</sup> February, 2020 considered the matter and the committee decided to issue last reminder letter. Accordingly, as per the decision of SRC a last reminder letter was issued to the institution on 26.02.2020. The institution vide letter dated 26.02.2020 submitted its reply to the last reminder letter.
- 10. AND WHEREAS, the SRC in its 388th Meeting held on 14th & 15th September, 2020 considered the matter and decided to issue withdrawal order. Accordingly, as per the decision of SRC a withdrawal order no. F.SRO/NCTE/APS00258/B.Ed/TS/2020/118865-8871 dated 24.09.2020 was issued to the institution.
- 11. AND WHEREAS, aggrieved by the order of the SRC, the institution preferred an Appeal before the Appellate Authority of the NCTE. The Appellate Authority vide order no. F.No.89-248/E-169781/2020 Appeal/31<sup>st</sup> Mtg-2020/4<sup>th</sup> December, 2020 dated 24.12.2020 appeal remand back the Order appealed against. The institution vide letter dated 29.12.2020 submitted reply to the appeal remand back case.
- **12. AND WHEREAS,** the SRC in its 393<sup>rd</sup> meeting held on 05<sup>th</sup> 06<sup>th</sup> January, 2021 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made: -

The Committee on the perusal of the reply submitted by the institution, and decided that the continuation order be issued to the Institution Aradhana College of Education, Telangana for B.Ed programme for 2 basic units of (50 students each unit). In addition to the above, the Shifting of premises of the institution to its own new permanent building at Aradhana College of Education, S. No. 36, 37/A, 37/E, 37/AA, Kismatpur (V), Rajendranagar (M), R.R. Dist, Telangana - 500086 is also hereby permitted.

13. NOW THEREFORE, this order is issued permitting the institution i.e. Aradhana College of Education, Rangareddy District – 501503, Telangana to shift its building at new address at Survey No. 36, 37/A, 37/E, 37/AA, Kismathpur (V), Rajendranagar (M), R.R. District-500086, Telangana run by Aradhana College of Educational Society, Kismathpur (V), Rajendranagar (M), R.R. District-500086, Telangana. Further as per the decision of the

SRC, an order for continuation of recognition for B.Ed course of two years duration with an intake of 100 students (two units) of 50 students each subject to fulfilment of the following conditions:-

- I.The Endowment fund of Rs. 5 lakhs and Reserve fund of Rs. 7 lakhs kept in joint account with Regional Director of NCTE should be maintained perpetually. Raising loan against the FDRs or mortgaging them shall not be done.
- II.The institution shall comply with the various other norms and standards prescribed in the NCTE Regulations, 2014 as amended from time to time.
- III. The institution shall make admissions only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.
- IV. The institution shall ensure that the required number of academic staff duly approved by affiliating body for conducting the course should always remain in position.
- 14. Further, the institution is required to fulfill all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University /Body, the State Government etc. as applicable.
- 15. The institution shall submit to the Regional Committee as Self Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a Chartered Accountant.
- 16. The institution shall maintain its Website with hyperlink to the Council and the Southern Regional Committee, covering, inter alia, the details of the institution, its locations, name of the programme(s) with intake; available of physical infrastructure, such as land, building, office, classrooms, and other facilities of amenities; instructional facilities, such as laboratory and laboratory and library and the particulars of their teaching faculty and non-teaching staff with photographs, for information of all concerned. The information with regard to the following shall also be made available on the website namely:
  - a. Sanctioned programme(s) along with annual intake in the institution:
  - b. Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
  - c. Name of faculty members who left of joined during the last, quarter:
  - d. Name of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
  - e. Fee charged from students;
  - f. Available infrastructural facilities;
  - g. Facilities added during the last quarter;
  - h. Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
  - i. The affidavit with enclosure submitted along with application.
  - j. The institution shall be free to post additional relevant information, if it so desires.

- k. Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
- 17. The institution shall adhere to the mandatory disclosure in the prescribed format and display up-to-date information on its official website.
- 18. The institution shall make available the list of students admitted on its official website.
- 19. The institution shall fill the information on GIS Portal on the NCTE Website.

If the institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made of issued there under, the institution will render itself vulnerable to adverse action including withdrawal of recognition by the Southern Regional Committee under the provisional of Section 17(1) of the NCTE Act, 1993.

Also order that a copy of this Order be published in the official Gazette.
